

IMPERIAL EDICT n. 002/2020

An edict to establish the titles of the House of Hartmann-Peters.

We, the Occidian Emperor, in exercise of Our constitutional prerogatives, proposes:

ARTICLE 01

In respect to the terms of the Act of Abdication and Viceroyalty, signed on 07 August 2020, it was agreed that all titles granted to members of the House of Hartmann-Peters would be maintained.

ARTICLE 02

The titles, to be maintained, and their holders, by order of precedence, are:

- ➤ His Imperial Majesty, Emperor Wilhelm, King in Illinois, Archduke of Karnia and of Hemyland, Grand Duke of Imvrassia, Margrave of Kardahar, Prince from Prussia and of New Europe, Prince of Hartmann, Lord of Chicago and of the Brook;
- ➤ His Imperial Highness, **Prince Wilhelm**, Prince of Ohio, Archduke of Karnia, Prince from Prussia and of New Europe, Hereditary-Prince of Hartmann;
- ➤ His Imperial Highness, **Hereditary Prince Jonathan**, Duke of Runtenram, Prince from Prussia and of New Europe;
- ➤ His Grace, **Kenneth**, IV Baron of Portage.
- ➤ Her Grace, **Joan**, Lady Peters-Migon;
- ➤ His Grace, **Herbert**, Lord Peters;
- ➤ His Grace, **Wade**, Lord Peters;
- ➤ Her Grace, **Ashley**, Lady Peters-Pepe;
- ➤ His Grace, **Nicholas**, Lord Peters:
- ➤ His Grace, **Andrew**, Lord of Portage;
- ➤ Her Grace, **Amanda**, Lady of Portage;
- ➤ Her Grace, **Christine**, Lady Peters-Novack;
- ➤ His Grace, **Daniel**, Lord Peters;
- ➤ His Grace, **Matthew**, Lord Peters;
- ➤ Her Grace, **Dani**, Lady Peters;
- ➤ Her Grace, **Nicole**, Lady Peters;

- ➤ His Grace, **Michael**, Lord Peters;
- ➤ His Grace, **Daniel**, Lord Peters;
- ➤ Her Grace, **Nina**, Lady Peters;
- ➤ Her Grace, **Katherine**, Lady Peters.

ARTICLE 03

The order of precedence and other dynastic dispositions may be decided by the Head of House of Hartmann-Peters.
